PAYMENT: ENCLOSE MONEY ORDER (MADE PAYABLE TO THE IRF, INC.) WITH APPLICATION. ALL MONIES MUST ACCOMPANY APPLICATION. NO APPLICATION WILL BE CONSIDERED WITHOUT PROPER PAYMENT. NO CHECKS ACCEPTED.

CERTIFICATE OF INSURANCE: A CERTIFICATE OF INSURANCE (ONE MILLION DOLLARS IN GENERAL LIABILITY) MUST BE PROVIDED WITH THE COMPLETED APPLICATION. IRF, INC. MUST BE NAMED AS AN ADDITIONAL INSURED ON THE CERTIFICATE.

WATER WILL BE AVAILABLE. PARKING IS AVAILABLE ON THE SIDE STREETS ON A FIRST COME BASIS. NO PARKING IS ALLOWED IN BOOTH AREA.

A GREASE TANK WILL BE PROVIDED FOR THE VENDOR'S USE ON EAST 3RD STREET AND PARKERSON NEAR DUMPSTER. ABSOLUTELY NO DUMPING OF GREASE IS ALLOWED IN THE BOOTH AREA OR CITY SEWER SYSTEM. ANY REPORTS OF DUMPING IN THESE AREAS WILL RESULT IN IMMEDIATE DISMISSAL FROM THE INTERNATIONAL RICE FESTIVAL.

ALL TRASH MUST BE BAGGED FOR PICK UP ON THURSDAY, FRIDAY AND SATURDAY NIGHTS. NO LOOSE TRASH WILL BE PICKED UP. VENDORS SHOULD KEEP THEIR BOOTH SPACE CLEAN OF TRASH AND DEBRIS BY USING A TRASH CAN WITH CAN LINERS.

THE USE OF A PORTABLE GENERATOR IS ONLY ALLOWED DURING SETUP ON THURSDAY.

ALL VENDORS WILL RECEIVE THEIR BOOTH ASSIGNMENT PRIOR TO THE FESTIVAL. BOOTH SPACES MAY NOT BE TRANSFERRED OR OTHERWISE ASSIGNED UNLESS CLEARED WITH THE RICE FESTIVAL OFFICE. BOOTHS WITH SIMILAR ITEMS WILL BE SEPARATED TO THE BEST OF OUR ABILITY. ALL BOOTHS ARE TO BE TORN DOWN IMMEDIATELY AT MIDNIGHT ON SATURDAY, OCTOBER 18, 2025.

DUE TO RECENT SAFETY CONCERNS, CITY OF CROWLEY ELECTRICAL SUPPLIER, CLECO, HAS MANDATED THAT THE IRF VENDORS BE OBLIGATED TO CONFORM TO CURRENT CODES. THE VENDORS ARE RESPONSIBLE TO PROVIDE ELECTRIC WIRE FROM THEIR RESPECTIVE BOOTHS TO THE DISCONNECT PANEL. YOUR BOOTH IS REQUIRED TO SUPPLY A LEVITON CAT. # 2711, NEMA # 14-30P OR EQUIVALENT PLUG CONNECTED TO A 10-4 SO CORD. IF YOU DO NOT HAVE ACCESS TO THE REQUIRED PLUG AND WIRE, FEEL FREE TO CONTACT BRAD MALOZ, ELECTRICIAN, AT 337-349-6693 AND HE WILL PROVIDE THE NECESSARY ELECTRICAL SUPPLIES TO PUT YOU IN COMPLIANCE AT A COST TO BE DETERMINED BY HIM.

- 7. VENDORS/EXHIBITORS ARE ENCOURAGED TO BRING PORTABLE GENERATORS FOR USE PRIOR TO AND DURING BOOTH SET-UP TIME, AS SAFE ELECTRICAL HOOK-UP MAY BE A LENGTHY PROCESS ON THURSDAY EVENING. WHILE THE USE OF SUCH GENERATORS IS ALLOWED AND ENCOURAGED FOR PRESERVATION OF SUPPLIES, ETC., DUE TO FUMES, SURGES, AND OTHER SAFETY CONCERNS, THE USE OF PORTABLE GENERATORS IS ALLOWED IN THE FESTIVAL BOOTH AREAS ONLY FROM 5PM ON THURSDAY UNTIL SUCH TIME AS MAIN FESTIVAL ELECTRICITY IS DELIVERED TO THE VENDOR'S BOOTH SPACE. ONCE MAIN ELECTRICAL HOOK-UP HAS BEEN ACCOMPLISHED, THE USE OF ANY GENERATORS IS STRICTLY PROHIBITED:

Re: International Rice Festival Licensing & Permitting

This year the International Rice Festival will be held October 16-18, 2025. If you will be having a booth this year a license is required by 4:30 p.m. on Thursday, October 17, 2022. Permits purchased after 4:30 p.m. will double in price. The license fee is \$175. If you own a business in the City of Crowley the fee is \$50.

To apply for a Rice Festival License, you must register with the Acadia Parish School Board. A clearance of sales tax form must be turned I with your license application for it to be processed. Acadia Parish Sales Tax Office is located at 2122 N. Parkerson Avenue, Crowley, LA 70526. Acadia Parish Sales Tax Office telephone number is 337-788-7820.

Also, a permit for an electrical safety inspection is due on the above date. The fee for an electrical safety inspection permit is \$75. If you are located on a private lot, the fee is \$75. This fee can be paid with the license fee at Crowley City Hall.

If you cannot make it to the International Rice Festival Office or Crowley City Hall by the above-mentioned date, you may obtain your license or permit by mail or payment may be made by phone. To obtain a permit or license by mail you must mail your fee to the City of Crowley, P. O. Box 1463, Crowley, LA 70527-1463, or call Korie Ardoin for Occupational License and Brandi Spell for Electrical Safety Permit (337-788-4100). A copy of the license application is attached.

Streets are now complete with underground wiring this year. Due to safety concerns City of Crowley electrical supplier, CLECO, has mandated that the Rice Festival vendors be obligated to conform to current codes. The vendors are responsible to provide electric wire from their respective booths to the disconnect panel. Your booth is required to supply a Leviton Cat. # 2711, NEMA # L14-30P or equivalent plug connected to a 10-4 SO Cord. YOUR BOOTH WILL NEED AT LEAST A 125 FOOT CORD TO REACH THE CONNECTION. Make sure you anticipate needing additional wiring for rise length. If you do not have access to the required plug and wire, feel free to contact our electrician, Brad Maloz at 337-349-6693 and he will provide the necessary electrical supplies to put you in compliance at a cost to be determined by him.

We are also requesting on behalf of the Mayor and City Administration that all vendors keep in mind that the streetscape project downtown has been done to revitalize our downtown historic area and are asking you to help keep our streets clean and neat. Additional trash bins will be placed on the side streets and along the food court for your convenience. Please do not take the waste cans and put them in your vendor booths. The waste oil cans will be located on 4th Street near the port-o-lets.

Because of the new street and median construction, we will have grass on the medians and would encourage all vendors to provide plywood for the floors of the booths that will have tents and under the tires of the trailers.
