RULES AND REGULATIONS

- 1 To be eligible to compete for the title of International Rice Festival Queen, young ladies must be 17 years of age on or by October 18, 2025 and not older than 23 years of age. Contestant must be a natural born female.
- 2 Entry is open to all young ladies who meet the requirements. However, those young ladies whose **primary residency**, not temporary school related housing, makes them eligible to compete for the title of Miss Crowley, "Zoned for an Acadia Parish Public School," will only be allowed to enter if they are sent through an official bid from another fair, festival or pageant.
- 3 Each contestant must have a sponsor who will be responsible for the entry fee of \$200. The sponsor may be a fair, festival, city, town, civic organization or business.
- 4 A contestant must be single and have never been married or had a marriage annulled. If she should marry or become pregnant before her one-year reign is over, she must relinquish her crown & title.
- 5 A contestant must not be nor ever have been pregnant or have ever borne a child.
- 6 In the event that a contestant participating in the International Rice Festival Queen's Contest has in her possession any substance that violates the Controlled Substance Penal Code Act, she will be disqualified and no refund of entry fees or any expenses will be given.
- 7 Contestants must be of good moral character and have never been arrested for and/or convicted of a crime (misdemeanor or felony) and are to conduct themselves in a professional manner at all times.
- 8 All contestants will be housed at accommodations provided by the International Rice Festival. Contestants are not allowed to have assistance with hair or make-up.
- 9 Contestants' formal gowns for presentation on stage during the 88th IRF Queen's Contest will be white or ivory.
- 10 Contestants must attend all functions that are listed on the Contestants' Itinerary. Transportation will be provided to and from all events by the International Rice Festival and contestants must remain with the group at all times. The 88th IRF Queen and her Court are expected to remain at the Festival and participate in all functions until the completion of the Grand Parade on Saturday afternoon. Participation in these events for all other contestants is optional.
- 11 If crowned IRF Queen, one must be available during her entire reign to represent her title at various functions. She will have the option to represent IRF in the 2026 LAFF Queen's Pageant, but not may participate in any other pageant as a contestant. A contract meeting will be held with the International Rice Festival Board of Directors, the Queen and the Queen's Parents on or before the 1st Tuesday in November at 6:30 pm where the Official Queen's Contract will be signed. However, it is agreed and acknowledged that a copy of the Contract has been provided to all contestants, it has been read and is understood, and that the rules of said Contract will begin at the time that the 88th IRF Queen is crowned.
- 12 No contestant competing for the title of IRF Queen shall promote herself by creating a contestant page on any social media platforms, including but not limited to Facebook, Instagram, Twitter, etc. The use of hashtags, memes, etc. is also forbidden, example #IRFcontestant, #RiceQueen(year), etc. Contestants will also refrain from promoting themselves as a contestant by appearing at any IRF event without express permission/invitation from the IRF Queen's Contest Chairperson or the IRF Board of Directors.
- 13 By signing below, contestants and/or parents or legal guardians of minor contestants authorize the International Rice Festival to use the contestant's information, including name, bio and photograph for publicity related to the 88th IRF Queen's Contest. It is understood that this authorization allows for use on social media sites, such as but not limited to Facebook, along with any other local media outlets.

I have read & completely understand the above rules & regulations. My signature binds me to said rules & regulations & shows my consent to comply. I understand that failure to abide by these rules & regulations may result in my disqualification from the International Rice Festival Queen's Contest.
